Part A: Pupil premium strategy plan

Statement of intent

At Gastrells Community Primary School we have high expectations for all pupils in our school, and believe that with great teaching, effective engagement with parents and a personalised approach to meet children's individual needs, every child can fulfil their individual potential, both academically and socially. In order to do this, we engage in a range of strategies to issue challenge at an appropriate level and provide support to overcome barriers to learning. We provide a rich and varied curriculum, which makes an exceptional contribution to pupils' outcomes so that children are engaged and achieve well. Key interventions and approaches are adopted on a whole school level and are not only restricted to pupils eligible for the Pupil Premium.

Our ethos is built around the core values of P.R.I.D.E.:

- **Positivity:** We approach every day with a positive mindset, encouraging students to embrace challenges and celebrate their successes.
- **Respect:** We show respect for ourselves, others, and our environment, creating a safe and supportive community for all.
- **Inclusivity:** We welcome and value diversity, ensuring that everyone feels a sense of belonging and has equal opportunities to succeed.
- **Determination and Challenge:** We are committed to helping students develop resilience and a growth mindset, empowering them to overcome obstacles and reach their full potential.
- **Excellence:** We strive for excellence in all aspects of school life, from academic achievements to personal development, inspiring students to aim high and achieve their best.

Some specific interventions and school initiatives have been made possible by allocating the Pupil Premium and/or catch-up funding. Our strategies target the individualised needs of our children in receipt of Pupil Premium, with the main aim being that these children do as well as their peers with similar starting points, who not eligible for the Pupil Premium. School leaders at Gastrells Community Primary School are committed to ensuring that all of our disadvantaged pupils, including those who are able, gifted and talented, receive high quality teaching in every lesson and that disadvantaged children who have 'fallen behind' their peers with similar starting points receive frequent intervention and daily support. Funding is allocated within the school budget by financial year. The budget enables us to plan our intervention and support programme year on year, based on the needs of the current cohort of children in receipt of Pupil Premium funding. When making decisions about allocating our Pupil Premium Funding, we have

analysed our data thoroughly and have made use of a range of research, such as the Education Endowment Foundation and The Sutton Trust.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	A percentage of our pupil premium children have additional needs (some are in the communication and interaction centre.) These children have additional support needs. 19% of our PP children have EHCP (87.5% are on the SEND register)
2	Since Covid has many children have begun school and are not as school ready, this is particularly with these who are entitled to Pupil Premium. (this continues to be the case in reception children 2024) Many of these children missed out on important developmental interaction in the early years of their lives. This is still impacting on children in different year groups in different ways.
3	Poor language skills. This includes speech and language difficulties and a lack of exposure to a wide range of vocabulary. (see above)
4	Risk of pupils in receipt of pupil progress making less than expected progress than their peers with similar starting points, especially in Writing.
5	Many of the children on PP have ACEs which includes cost of living is affecting many families at Gastrells – this can mean that schooling and education is not at the forefront of priorities.

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

Internal assessments show that the performance of disadvantaged pupils was lower than the national in key areas of the curriculum for children within KS1 however 2/5 (40%) have an EHCP and 4/5 (80%) are on the SEND register.

In KS2 SATs assessments 4/4 children who had pupil premium were on the SEN register and 50% of them had an EHCP. These children all made individual progress but did not reach the expected standard.

Although overall attendance in 2023-24 was 92.2%. The attendance of PP children was lower than the targeted 95%. We had one child who was a non attender (also on a My Plan+) – without their data in the data set the attendance was 86.6%.

Our assessments and observations indicated that pupil behaviour, wellbeing and mental health were significantly improved from the previous year following on from a year significantly impacted by COVID-19-related issues. The impact was particularly acute for disadvantaged pupils. We continued to use pupil premium funding to provide wellbeing support for all pupils, and targeted interventions where required. Children completed questionnaires, and those on PP overall did not have higher mental health and wellbeing issues.
